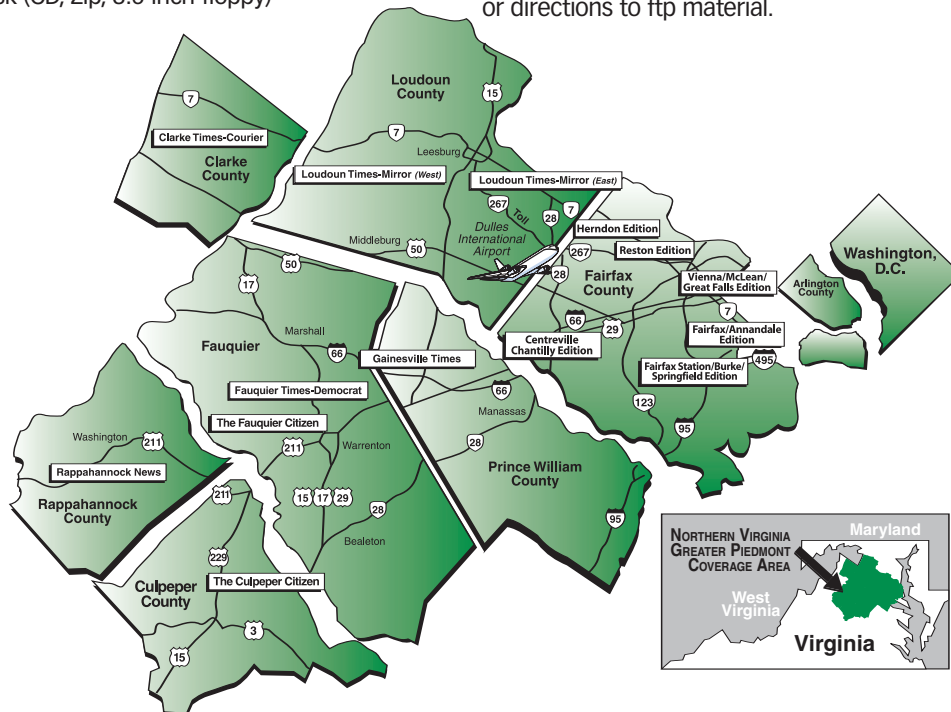

{TERMS OF ADVERTISING}
