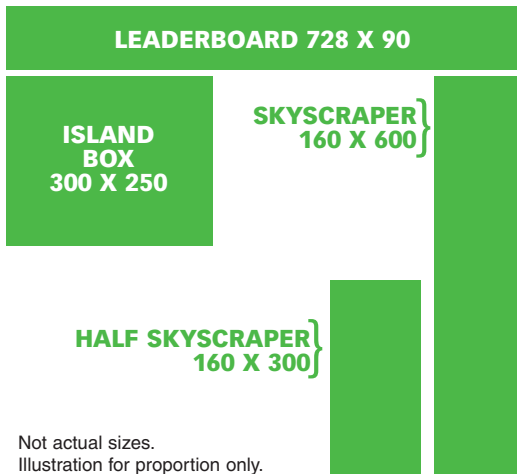

Additional modifications submitted during the contract period will be processed for a fee of \$(100) per modification. **52 week contract - 3 free changes / 26 week contract - 2 free changes / 13 week contract - 1 free change.**
